Holiday Bazaar Rules:

1. Vendors will occupy a single stall that will fit up to a 12 x 12 foot tent, and may be allowed to occupy a double stall if space is available (this is not guaranteed).
2. Vendors will not be allowed to park in their stall spaces. Vendors may park in the street to unload their vehicles, but should remove everything from their vehicle, park their car, and walk back to their stall space. (This will be a one-minute walk, at a minimum).
3. Vendors will be ready to sell at 10 a.m. and will tear down at 3 p.m. Set up can begin as early as 8:00 a.m.
4. Vendors cannot leave the Holiday Bazaar once it is open.
5. If a vendor sells out, they may place a "sold out" sign in their booth, and leave the market until tear down, but their set up must remain in place until tear down due to public safety.
6. A vendor's set up location cannot be pre-selected by the vendor (you may request if you would like to be by someone specific, but requested placement is not guaranteed).
7. Vendors agree to set up at the Holiday Bazaar in rain or shine weather.
8. Electric *will not* be available for the Holiday Bazaar. Small generators are allowed.
9. Vendors may park in the street to unload their vehicles, but should remove everything from their vehicle, park their car, and walk back to their stall space. (This will be a one-minute walk, at a minimum).
10. Vendors must wear masks for the duration of the event and social distancing is encouraged.
